

Hinckley Institute Launches International Internship Program

ith a generous grant of \$200,000 from Asian philanthropist Li Ka-shing, the Hinckley Institute will expand its global presence. In addition to the recently-established internships through the U.S. State Department and with the Scottish and Mexican parliaments, the Institute will now send students to India, China, Taiwan, England, Greece, Thailand, South Korea, Japan and other countries throughout the world. Students in the program gain access to top government, political, and public policy offices and receive a stipend to cover their travel and living expenses.

Hinckley Institute Director Kirk L. Jowers stated, "The remarkable support of the Hinckley family and Hinckley Institute friends, students, and staff has enabled the Hinckley Institute to create the top national and local internship program in the nation. Mr. Li's generous donation will assist the Hinckley Institute in expanding its reach and permitting students to gain a practical understanding of the people, politics, and policies of the world. This experience will make them more marketable as they leave college and better-trained to become future political and business leaders."

The international internship program will also play an integral role in fulfilling the university's goal of expanding its international focus and offerings. "We are eager for our students to immerse themselves even more deeply in different cultures, languages and systems of governance; to become socially and politically literate and economically aware," said University President Michael K. Young. "The Hinckley Institute's Li Ka-shing Global Internship Program provides an incredible platform to accomplish these goals."

In Memory of Dr. R.J. Snow (1937-2006)

Snow, the second director of the Hinckley Institute of Politics, serving from 1975 to 1985. R.J. was an extraordinary scholar and administrator and a mentor, friend and example to many. While his loss is painful and we will miss him dearly, he leaves a lasting legacy of love for our country and unmatched devotion to students and higher education.







The Legacy of R.J. Snow: Deseret Morning News Editorial

he people who leave the most lasting legacies are often those who don't worry about such things while they're alive. Such seems to be the case with R.J. Snow, the former University of Utah and Brigham Young University vice president who died on Tuesday in an automobile accident near his home. Snow, 68, was just preparing to teach his final political science course this summer before retiring. At a time when nerves in the state and nation are strained and tensions are often pulled taut, the loss of R.J. Snow is like the loss of a great athlete during crunch time. He was taken at a crucial moment. He was at the top of his game. Still, given all that, one hopes the life he lived will now resonate even stronger; that those who are left to grapple with the problems of politics, education and society will find his memory and meaningful example — his legacy — calling forth in themselves R.J. Snow's hallmark decency and civility.

Hinckley Institute Hosts National Redistricting Reform Conference

n April 2006, the Hinckley Institute of Politics welcomed prominent national and state leaders from several leading government reform organizations and national interest groups to Utah for a conference aimed at examining the strategies, tactics, and tools necessary for implementing redistricting reform in various states throughout the country. Sponsored by the Campaign Legal Center, League of Women Voters, and Council for Excellence in Government, the three-day conference addressed key aspects of redistricting reform efforts including timing, process, coalition building, public outreach, and message development. Guests of the conference included Trevor Potter, former chairman of the Federal Election Commission, Thomas Mann, Brookings Institution, and David Skaggs, former Member of Congress. Hinckley Institute Teams with Harvard to Promote Civic Engagement

he Hinckley Institute continues its involvement in Harvard University's National Campaign for Political and Civic Engagement. As one of the few institutions selected to join the National Campaign, the Hinckley Institute of Politics sends two students each year to the Kennedy School of Government in Cambridge Massachusetts for a weekend of training and planning. This year, University of Utah students Patrick Reimherr (Director of VoteProject 1824) and Ingrid Price (Director of the ASUU Government Relations Board) joined students from across the country in formulating strategies to increase civic engagement among college students.

Vote Project combined forces this fall with the ASUU Government Relation's Board to register students to vote and remind those already registered to vote. The registration drives started in late August, and continued, two to three times each week, through the month of September and October. Hundreds of students registered to vote, and many of those already registered pledged to vote in November. A "Get out the vote day" complete with campaign signs, a College Republicans/College Democrats debate and tabling to reminded students to go out the next day and vote.

This year's seminar offered 30 teachers the oppor-




Contributing articles address pertinent state, national, and international issues by illuminating key problems and potential solutions and adhering to the highest standards of political research and analysis.

Alec Russell: Hinckley Fellow, January 23-24, 2006

lec Russell serves as the Washington Bureau Chief for the Daily Telegraph, England's largest newspaper with a readership of more than 4.9 million people each week. Previously he was the Daily Telegraph's foreign editor in London. He also has had postings in the Balkans and in Africa and has written books about both assignments.

During his visit, Mr. Russell met with student leaders, taught classes on news writing and the role of the media in politics, interacted with university faculty, interviewed notable Utahns including Governor Jon Huntsman, Jr. and Dallin H. Oaks, and met with and was interviewed by local media outlets. In his Hinckley Forum, *The Odd Couple: Bush and Blair*, Mr. Russell spoke to a full crowd of students and community members on the foreign-policy alliance between the U.S. and Great Britain and the future of their relationship.

Governor Brian Schweitzer: Hinckley Fellow, March 20-21, 2006

After graduating with a degree in Botany from Montana State University, Brian Schweitzer began a career in irrigation development – traveling to Africa, Asia, Europe, and South America. After returning to Montana to start a ranching and irrigation business, he served in various positions including the Montana State USDA Farm Service Agency Committee, Montana Rural Development Partnership Board and National Drought Task Force. On November 2, 2004 he was elected as Montana's first Democratic governor since 1988 and became the 23rd Governor of Montana on January 3, 2005.



Dr. Larry Sabato: Hinckley Fellow, November 13-15, 2006

ccording to the *Wall Street Journal*, Dr. Sabato is "the most quoted college professor in the land." A former Rhodes Scholar and Danforth Fellow, he received his B.A. in government from the University of Virginia in 1974, completed a year of graduate study in public policy at Princeton University's Woodrow Wilson School of Public and International Affairs, and studied at Queen's College, Oxford University. As founder and director of the University of Virginia Center for Politics, Dr. Sabato has taught more than 13,000 students, authored more than 20 books and made national media appearances on several news programs. Dr. Sabato's political analysis and predictions, featured on his *Political Crystal Ball* website, have earned him the reputation of being one of the most accurate political forecasters in the nation.

Dr. Sabato's visit to the Hinckley Institute included meeting with high school teachers, speaking to students of the S.J. Quinney College of Law, directing a student leader training on civic engagement, meeting with state and local elected officials, giving the keynote address at the Utah Coalition for Civic, Character, and Service Learning's 2006 Dialogue on Democracy Dinner, and speaking at a Hinckley Forum entitled The Political Crystal Ball.

Featured Internships

House Committee on International Relations

Zan Larsen served as an intern for the House International Relations Committee with the Democratic Staff. The opportunity this internship presented and the growth she experienced could not be replaced by any class. Her favorite experience is one that will stay with her forever. Towards the end of the summer, the staff member in charge of the Human Rights Caucus asked her to pick a topic and organize a Congressional Briefing. She chose Divorce Law in the Middle East. Researching and preparing information packets, finding expert witnesses, and getting co-sponsors for the briefing was an incredible chance to experience working on Capitol Hill.

Senate Joint Economic Committee

Matt Homer's experiences at the Senate Joint Economic Committee ranged from attending congressional briefings and committee hearings to writing reports on conservation tax credits and trade negotiations. He also helped produce a report on the state of Utah's economy which was eventually published on the U.S. Senate web site. Working in the Senate gave him the opportunity to rub shoulders with many of our nation's leaders and be a part of the legislative process. Matt remarks that he "left Washington with a greater appreciation for our system of government, but also a salient knowledge that much improvement is needed."

Embassy of the United States in Lima, Peru

Joe Coccimiglio served a fall internship in the economic section of the Peruvian Embassy. He investigated U.S. and Peruvian interests and wrote reports (cables) to Washington. He also had the opportunity to work in the Peruvian Amazon. He investigated petroleum exploration, visited indigenous communities, met with several congressman, viewed gas pipelines several thousand feet high in a helicopter, and spent a night with an indigenous people deep in the Amazon. "I saw, first hand, the influence the U.S has on foreign economies. It was an adventure, and exceeded my every expectation."

Embassy of the United States in Vilnius, Lithuania

Patrick Wunderlich served as an intern at the U.S. embassy in Vilnius, Lithuania. By working with experienced Foreign Service Officers, Patrick was able to gain an in-depth look into the way U.S. foreign policy is conducted and what life is like living abroad. "My time in Vilnius has definitely changed the way I look at government; I would recommend this opportunity to anyone." Patrick quickly discovered during his internship that a large part of being an American overseas is dispelling myths that foreigners have about the United States. "A lot of the people I met perceived life in America as it is portrayed on MTV."

Republican Governors Association

One of the outstanding internship opportunities offered by the Hinckley Institute of Politics is with the Republican Governors Association (RGA). As an intern, Rich Whipple was responsible for researching and updating information about each of the gubernatorial races. 

Featured Internship Program: Utah State Legislature

ince 1969, the Hinckley Institute has provided the Utah State Legislature with staff aides to legislators, media organizations, and lobbyists. Legislative interns serve as full-time assistants to legislators during the sixweek Utah legislative session and perform important duties such as issue research, bill tracking and analysis, speech writing, attending committee meetings, and assisting with constituent correspondence. Few other opportunities are as hands-on as a legislative internship. Students in the program gain unparalleled access to the inner workings of Utah government and the legislative process as they work side-by-side with Utah's leaders. Students also forge strong relationships with legislators, legislative staff, and other interns that often lead to future opportunities. Many of our legislative interns have gone on to manage political campaigns, lead interest groups, and serve as members of the Utah State Legislature.

The Hinckley Institute continues its tradition of supplying the Utah State Legislature with the brightest and most prepared students that the University of Utah has to offer. As an integral component of the legislative internship program, students are required to take Political Science 3900, Legislative Internship Preparation, during the fall semester prior to the legislative session of their internship. This course is taught by Dr. Dan Jones of the University of Utah Political Science Department and Jerry Howe of the Utah Office of Legislative Research and General Counsel. The course prepares students for their legislative internship by introducing them to the intrica-

Students in the Campaign Management Minor take courses such as *Political Management (Dave Buhler)*, *Interest Group Politics and Lobbying (Dr. Ronald Hrebenar)*, *Legislative Process (Dr. Robert Benedict)*, and *Voting, Elections and Public Opinion (Dr. Dan Jones)*. A political internship through the Hinckley Institute serves as the capstone project for the minor.

Karen Shepherd Fund Celebrates 10th Anniversary

s a partner with the Hinckley Institute, the Karen Shepherd Fund provides stipends to interns for Democratic candidates running in local, state, and federal campaigns in Utah. A former member of the Utah Senate and the U.S. House of Representatives, Karen Shepherd established the program from funds remaining from her final campaign in 1994. An advocate for integrity in government, she requires each candidate who takes an intern to pledge they will support laws regulating campaign finance reform, lobbyist disclosure, and gift ban legislation. The Fund has now been supporting students for 10 years.

Interns agree to work 12 to 15 hours a week for the semester preceding the election and they are paid a stipend of \$50 per week for the length of the internship upon completion of the campaign and a written evaluation of their experience.
